**B. Criteria for application:**

To be considered for the Fellowship, applicants need to be: *(exceptions can be made in some extraordinary cases)*

- Minimum 18 years of age
- Interested applicants should be from rural, tribal communities from the four states of Rajasthan, Madhya Pradesh, Jharkhand and Chhattisgarh in central India.
- Be ordinarily resident in one of the 4 focus states in Central India
- Have strong communication skills in at least one local language
- Have completed class 12th or be 18 years of age
- Have strong interest in working with communities on conservation of nature/ agrobiodiversity / traditional knowledge, environment and social change
- Be willing to commit 10 months for training and internship.
- Have basic fitness and willingness to work in physically challenging outdoor locations

**\* *Please note:***

- *Applicants from marginalized communities and economically weaker sections will be given priority.*
- *The Green Hub is committed to providing equal opportunities to both women and men.*
- *Applicants must not have any affiliation with any political party.*
- *Basic reading and writing skills in Hindi and English is preferred (preferred, not essential).*
- *Applicants should have the ability, willingness and be fit enough to work effectively in challenging environment, especially outdoors.*
- *Consent of parents / guardians is required (especially between ages of 18-21 years)*
